**130,000m2 of secured and guarded warehouse space plus additional 200,000m2 under open sky at the border to Poland for goods to Ukraine**

Dear Mr Gsänger,

I was informed by Yevgeni Mykhalchenko, that there is a huge demand of warehouse space for goods that need to be delivered to Ukraine systematically.

International Power Invest AG, is a Swiss based investment Holding, investing in renewable energies and sustainable technologies worldwide. We own and operate photovoltaic systems, batteries for grid stabilization, charging stations for electric vehicles as well as recycling plants and real estate.

We've been doing business in the energy sector in Ukraine successfully and now we are giving something back to the country and its people.

We own a large logistic centre in the North of Germany, at Libnower Landstraße 1, 17390 Murchin, close to the Baltic Sea. There, we have 130,000m2 of warehouse space and 200,000m2 of space under the open sky, which is guarded and secured. Besides this, we have a high-tech office centre there.

The site is next to Anklam, 20km from the German- Polish border, in the North of Germany, 80 km from Stettin, Poland. Close to our site is the railway station of Anklam and the airport of Heringsdorf.

Since the first day of the war, we are bringing Ukrainian women, children and elderlies from the Polish- Ukrainian border to our headquarters. Here we are organizing accommodations for the help seeking people. We have organized everything software based and thus automated the entire process.

As a result, everything runs in a controlled and systematic way, which makes it much easier for the refugees, the government and for us. Even the registration and application to the government are automatically created by our system for the refugees.

We allocated 500,000 Euro in our budget for this help, and we are getting additional support from business partners and other people that want to help.

At our headquarters, where the warehouses are located, we have 35 employees, who are taking care of the refugees already and who can take care of the goods that need to go to Ukraine.

I can assure, that the receipt of the goods as well as the goods issue and of course storing the goods, can be made in a correct way by my employees.

We have the necessary forklifts and other hardware to take care of the goods.

Our logistic centre is surrounded by a 2,5 m high wall and razor-barbed wire, monitored, and controlled by CCTV and protected 24/7 by a security force, since we are also storing government reserve for the German government.

We can store goods inside of our warehouses, currently at least 100,000 europallets on the ground level and we can store goods like machines, cars etc. outside on more than 200,000 m2. Besides this, we have a new and very modern office building, where we have 2,800 m2 office space. Currently, we have workspace in the office available for 30-40 office workers.

We can provide all the space that we have, and our employees can do the work that is needed.

There is a huge lack of organization and structure for the goods, that are really needed by the State Emergency Service of Ukraine and other official organizations as well as the Ukrainian government.

We can organize and structure this help at our site and with our employees and volunteers.

If this offer is interesting for you and your members, please let us coordinate the help and logistics through our large logistic centre together, to ensure that all goods are going to the right organizations in an organized and structured way.
